By signing this application for a Special Event Street Closing Permit, you agree to indemnify, defend and hold harmless the City, its employees and agents, from any claims, suits, demands, actions or proceedings of any kind, and any injuries, damages, costs, including reasonable attorney's fees, expenses or losses of any kind by anybody arising from or relating to the street closing.

\*MUST APPLY TEN DAYS IN ADVANCE OF EVENT\*

\*Applications which are received less than ten days prior to the event must be accompanied by a \$50.00 surcharge in addition to the Application Fee, which will be refunded if the application cannot be processed before the event date.

If you are blocking or obstructing parking meters during the weekday (Monday thru Saturday), you will be charged a rate of \$12.50 per day per meter. This is in addition to the Application Fee and any late fee surcharge if applicable.

Prior to executing this permit, Traffic Engineering will require a copy of the entertainment license from the Board of Licences(BOL) or a communication from the BOL indicating no entertainment license is required. In addition Traffic Engineering will require a copy of the special events permit from the Department of Art Culture and Tourism (ACT) or a communication from ACT indicating no special events permit is required. The Applicant is required to contact BOL (401)680-5207 and ACT (401)680-5770 to obtain this documentation.
