What is the overall deductible?	Out-of-Network: <b>\$100</b> individual / <b>\$300</b> per member (maximum of 3 members) for a family plan	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
