

**SEASONAL MOORING Application for City of Providence waters**

The Providence Harbor Management Plan and the City of Providence Code of Ordinances Section 11-1.1 establish a seasonal mooring field consisting of eight (8) mooring spaces. The mooring field containing these spaces is located on the Seekonk River to the north of the Gano Park Boat Launch and south of the Crook Point Bascule Bridge west of the rowing lanes. Please note that the moorings designate spaces; recipients of such mooring spaces are required to supply their own moorings/mooring tackle. The **mooring spaces are for vessels up to 25 feet in length**. See page 2 of this application for details regarding minimum mooring tackle requirements.

Applications must be filed by February 1 (or, if deemed not practicable, by a later date determined in a publicly noticed meeting of the Harbor Management Commission prior to February 1). Submission of this application does not ensure that the applicant will be allocated a mooring; in the event that there are more applicants than designated mooring spaces a lottery shall be held prior to the allocation deadline to select recipients of the mooring spaces.

The applicant will be required to present proof of vessel ownership (State Registration and Title) at the time the mooring space is allocated.

The applicant must pay the annual mooring fee of \$350.00 on or before issuance of a mooring permit. This is an annual payment for a three-year permit period. At the end of the three-year period or in case of failure to pay the annual fee, the permit shall expire, though the permit-holder may re-apply for a permit. Permits are non-transferrable and the permit holder must be present on the vessel for which the permit is held. Please refer to the City of Providence Code of Ordinances Section 11-1.1, Harbor Moorings and Anchorages for additional regulations.

Permit allocation shall take place on March 1 (or, if deemed not practicable, on a later date determined in a publicly noticed meeting of the Harbor Management Commission prior to March 1). Failure to make payment by April 30 shall nullify allocation of the permit.
