EVICTION PROCESS AND TENANTS RIGHTS

Evictions: When are they Legal?



- Only a Judge can evict you.
- Legal evictions require your landlord to go to court.
- If your landlord tells you to move out, threatens you, or tries to move you out without going to court that is not legal.
- The Rhode Island Attorney General has advised police departments not to help landlords move people out unless there is a judge's order that requires you to move.

Evictions: What is the Process?



- The timing and process depends on whether you are evicted for not paying your rent or for any another reason.
- Non-payment of rent cases move faster. But because of COVID-19, fewer cases are being scheduled, which means they are taking longer to get to a judgment.
- If you are up to date on your rent but the landlord wants you to move out for other reasons (wants to raise the rent, wants to move someone else in) that process take more time and you will get more advance notice.

Evictions: Why Get Help?



- Landlords almost always have a lawyer and tenants rarely do.
- If your landlord is threatening to move you out or if you get court papers about an eviction it is importance to get advice.
- A lawyer can tell you whether what the landlord is doing is legal and how to respond depending on the issue (back rent, bad conditions in the house, other issues)
- A lawyer can also negotiate on your behalf, and potentially raise defenses or claims that can reduce the amount you have to pay or make you able to stay.

Where Can I Get Help?



- Rhode Island Legal Services can help residents of both private and public/subsidized housing. There are eligibility requirements. For private tenants, RILS helps those who fall below 200% of the federal poverty guidelines. Rhode Island Legal Service's Providence office can be reached at 274-2652.
- The R.I. Center for Justice can help residents in private
 housing who have income above the eligibility of Rhode Island
 Legal Services and some groups that Legal Services can't help.

What Can HNRI Help With?



- 1. HNRI has housing stabilization funds from four sources of funding that allow us to serve households from 0 -100% AMI (up to \$87,000/ annually for a household of 4 persons)
- 2. Depending on an applicant's circumstances, funding allows us to help with past due rent/ mortgage, late fees, upcoming rent, past due utilities, security deposit and moving expenses
- Breakdown of assistance provided:
 - \$41,752 in past due rent/mortgages
 - \$5,397 in past due utilities
 - \$3,050 in security deposits

- \$1,000 in moving expenses
- \$900 in upcoming rent

Who Does HNRI Help?



- 1. To date, HNRI has processed 97 applications for assistance and have awarded 31 households funding.
- 2. 7 of the awarded households have been from Providence.
- 3. Demographics of households served:
 - 21 have been female head of household
 - 23 households have identified themselves as non white and/or Hispanic
 - 42 adults and 71 children

What are HNRI Member organizations doing to support residents and clients during the COVID-19 crisis?



- 1. <u>House of Hope</u> (Warwick) received funds to help some of their residents with rental assistance payments, security deposits, hotel vouchers, and basic need items.
- 2. <u>Smith Hill CDC</u> (Providence) received \$20,000 in funding to assist Smith Hill residents with past due rent and mortgage payments.
- 3. <u>PCF Development</u> (Pawtucket/Central Falls) has introduced a rental relief program for their tenants, done outreach to connect residents with various rental assistance programs, partnered with Farm Fresh RI to deliver 100 Farmer to Family food boxes, delivered groceries, distributed gift cards for groceries and basic needs, partnered with the United Way and Centerville Bank to host a virtual "Housing Security and Stability" workshop and shared information about testing sites with its residents.
- 4. <u>NeighborWorks BRV</u> (Woonsocket/Northern RI) received funding to provide rental and utility assistance to in-need households and has offered past due tenants payment plans that work within their budget to allow them to catch up on rent and remain stably housed.

What is Housing Help RI?



Housing Help RI allows qualified households to receive:

- 1. Up to \$5,000 for past due rent, relocation costs, and utility arrearages.
- 2. Up to one month's rent support going forward
- 3. Housing stabilization support
- Referrals to RILS and CFJ for eviction defense legal supports





You may qualify for Housing Help RI if you:

- 1. Have lost income due to COVID-19
- 2. Had pre-COVID household income below 80% Area Medium Income (AMI)
- 3. Have a current lease with a landlord
- 4. Are not currently receiving rental assistance
- 5. Are not currently living in subsidized housing
- 6. Have lived in Rhode Island at least one year

What documentation will I need?



- Documentation reflecting loss of income due to the COVID-19 pandemic
- Lease with a landlord
- 3. Eviction notice and/or proof of rental arrears
- 4. W-9 from the landlord



What Other Housing Supports Are Available?



If you have been evicted and are homeless, you may qualify for other housing supports such as:

- 1. Diversion assistance and/or Rapid Resolution
- 2. Emergency Shelter
- 3. Rental Assistance
- 4. Permanent Supportive Housing

Crossroads Rental Assistance



We provide the following support and services:

- 1. An average of 12 months of rental assistance
- 2. Housing-based case management
- 3. Education & Employment support
