- YOU MAY have to attend a City Service Meeting. Once the application is reviewed by City staff, you will get an email notification about your meeting date(s). This will be sent to the email in the application. The City Service Meeting notification email will also contain information what you need to bring to your meeting. City Service Meetings are held on Wednesdays at 10AM via ZOOM.
