Any person knowingly and willfully making a false application or certification or knowingly and willfully aiding and abetting in the making of a false application or certification shall be guilty of a felony and shall be subject to the penalties provided for in section 17-26-1, [RIGL 17-20-8(D)].

Your application is a matter of public record, but your vote is confidential.
