Room 311, City Hall. 25 Dorrance Street, Providence.** At 2:15 P.M. all bids will be publicly opened and read at the Board of Contract Meeting in the City Council Chambers, on the 3rd floor of City Hall.

- Bidders must submit 2 copies of their bid in sealed envelopes or packages labeled with the captioned Item Description and the City Department to which the RFP and bid are related and must include the company name and address on the envelope as well. (On page 1).
- If required by the Department, please keep the original bid bond and check in only one of the envelopes.
- Communications to the Board of Contract and Supply that are not competitive sealed bids (i.e. product information/samples) should have "**NOT A BID**" written on the envelope or wrapper.
- Only use form versions and templates included in this RFP. If you have an old version of a form <u>do not</u> recycle it for use in this bid.

NOTICE TO VENDORS

- 1. The Board of Contract and Supply will make the award to the lowest qualified and responsible bidder.
- 2. In determining the lowest responsible bidder, cash discounts based on preferable payment terms will not be considered.
- 3. Where prices are the same, the Board of Contract and Supply reserves the right to award to one bidder, or to split the award.
- 4. No proposal will be accepted if the bid is made in collusion with any other bidder.
- 5. Bids may be submitted on an "equal in quality" basis. The City reserves the right to decide equality. Bidders must indicate brand or the make being offered and submit detailed specifications if other than brand requested.
- 6. A bidder who is an out-of-state corporation shall qualify or register to transact business in this State, in accordance with the Rhode Island Business Corporation Act, RIGL Sec. 7-1.2-1401, et seq.
- 7. The Board of Contract and Supply reserves the right to reject any and all bids.
- 8. Competing bids may be viewed in person at the Department of the City Clerk, City Hall, Providence, immediately upon the conclusion of the formal Board of Contract and Supply meeting during which the bids were unsealed/opened. Bids may also be accessed electronically on the internet via the City's <u>Open</u> <u>Meetings Portal</u>.
- 9. As the City of Providence is exempt from the payment of Federal Excise Taxes and Rhode Island Sales Tax, prices quoted are not to include these taxes.
- 10. In case of error in the extension of prices quoted, the unit price will govern.
- 11. The contractor will **NOT** be permitted to: a) assign or underlet the contract, or b) assign either legally or equitably any monies or any claim thereto without the previous written consent of the City Purchasing Director.
- 12. Delivery dates must be shown in the bid. If no delivery date is specified, it will be assumed that an immediate delivery from stock will be made.
- 13. A certificate of insurance will normally be required of a successful vendor.
- 14. For many contracts involving construction, alteration and/or repair work, State law provisions concerning payment of prevailing wage rates apply (<u>RIGL Sec. 37-13-1 et seq</u>.)
- 15. No goods should be delivered, or work started without a Purchase Order.
- 16. Submit 2 copies of the bid to the City Clerk, unless the specification section of this document indicates otherwise.
- 17. Bidder must certify that it does not unlawfully discriminate on the basis of race, color, national origin, gender, gender identity or expression, sexual orientation and/or religion in its business and hiring practices and that all of its employees are lawfully employed under all applicable federal, state and local laws, rules and regulations. BID TERMS

- Financial assurances may be required in order to be a successful bidder for Commodity or Construction and Service contracts. <u>If either of the first two checkboxes below is checked, the specified assurance</u> <u>must accompany</u> a bid, or the bid will not be considered by the Board of Contract and Supply. The third checkbox indicates the lowest responsible bidder will be contacted and required to post a bond to be awarded the contract.

- 2. Awards will be made within **sixty (60) days of bid opening**. All bid prices will be considered firm, unless qualified otherwise. Requests for price increases will not be honored.
- 3. Failure to deliver within the time quoted or failure to meet specifications may result in default in accordance with the general specifications. It is agreed that deliveries and/or completion are subject to strikes, lockouts, accidents and Acts of God.

The following entry applies only for COMMODITY BID TERMS:

4. Payment for partial delivery will not be allowed except when provided for in blanket or term contracts. **The following entries apply only for CONSTRUCTION AND SERVICE BID TERMS:**

- 5. Only one shipping charge will be applied in the event of partial deliveries for blanket or term contracts.
- 6. Prior to commencing performance under the contract, the successful bidder shall attest to compliance with the provisions of the Rhode Island Worker's Compensation Act, RIGL 28-29-1, et seq. If exempt from compliance, the successful bidder shall submit a sworn Affidavit by a corporate officer to that effect, which shall accompany the signed contract.
- 7. Prior to commencing performance under the contract, the successful bidder shall, submit a certificate of insurance, in a form and in an amount satisfactory to the City.

The City of Providence actively seeks Minority and Women business enterprises to participate in bids to meet the City's procurement needs. Pursuant to the City of Providence Code of Ordinances, Chapter 21, Article II, Sec. 21-52 (Minority and Women's Business Enterprise) and Rhode Island General Laws (as amended), Chapter 31-14, et seq. (Minority Business Enterprise), Minority Business Enterprise (MBE) and Women's Business Enterprise (WBE) participation goals apply to contracts.

The goal for Minority Business Enterprise (MBE) participation is **10%** of the total bid value. The goal for Women's Business Enterprise (WBE) participation is **10%** of the total bid value. The goal for combined MBE/WBE participation is **20%** of the total bid value.

Only businesses certified with the State of Rhode Island as minority and/or women business enterprises are counted towards the City's goals. Eligible minority or women-owned businesses are encouraged to seek certification from the State of Rhode Island Minority Business Enterprise Compliance Office at: http://odeo.ri.gov/offices/mbeco/

Bid Requirements:

Submission of this form is **required with every bid**. **Your bid will not be accepted without an affidavit**.

Verifying MBE/WBE Certification

The form must include all subcontractors utilized on the contract, both MBE/WBE and non-MBE/WBE, the total amount paid to each subcontractor for the given period and to date, A copy of all forms should be sent to the MBE/WBE Outreach Director Office, Grace Diaz at <u>gdiaz@providenceri.gov</u>. BID PACKAGE SPECIFICATIONS

SECTION 1: Background

On March 11, 2021, President Biden signed the American Rescue Plan Act (ARPA) of 2021 into law to bring direct and immediate relief to families and workers. The act provides \$350 billion in funding to states, counties, municipalities and other governmental units across the country. These funds-Coronavirus State and Local Fiscal Recovery Funds (SLFRF)- are to be used by state and local governments to address the devastating public health and economic impacts of the COVID-19 pandemic. Providence received approximately \$166M in SLRF funds, which were distributed via municipal ordinance into various categories in May 2021 and June 2022.

In June 2022, the City of Providence approved an ordinance which included \$10M for the COVID-19 Equities Program. The purpose of this funding is to address the lingering disparities resulting from injuries suffered by African Heritage and Indigenous communities as outlined in Truth-Telling and Reconciliation phases of a three-phase process. A municipal reparations commission was formed to provide clear recommendations to the City on appropriate policies, programs and projects to begin addressing lingering disparities. The commission authored a detailed 11-point investment strategy that articulates specific recommendations, grounded in community feedback and research, for how the City should spend the \$10M COVID-19 Equities Fund. Further, the commission authored a set of ARPA-compliant eligibility criteria that specifies the intended recipients of the funding and/or programming resulting in the administration of the \$10M. Details of the eligibility criteria can be found on pages 12-14 of the 11-point investment strategy report.

This program is considered to be a strategic collaboration of investments building upon the successful One Providence for Youth Program, and advancing the creation of a resident scholarship program. The path from high school through postsecondary education, to a good job, has long been a barrier for many Providence minority and low-income youth. In Rhode Island, there are large gaps in college completion between low income and higher income students, with 42% of low income students completing college within six years, compared to 75% of higher income students. In Providence, the percentage of 2020 college enrollees who persisted (enrolled for a third semester) was 61%.

Internships are a critical component of a students' resume, in fact more than ³/₄ of college students at four-year institutions complete an internship before graduation. It is estimated that 300,000 people intern each year in the U.S. However, financial barriers prevent minority and low-income youth and students from disadvantaged backgrounds from obtaining high-quality unpaid internships, and most youth will opt for a part time job while leaving career-rich opportunities and internships off the table. Hiring managers and employers identify internship experience as the differentiator when choosing between two equally qualified candidates. In fact, completion of an internship increases job offers by 16%.

The successful bidder must be able to formulate a strategic partnership with a scholarship entity to provide internship placements and scholarships to youth. Additionally, Providence businesses are encouraged to



partner with the applicant, to provide structured, work-based, career-potential opportunities for high school and college students during the summer and/or year-round as well. Youth will earn money while doing valuable work in high wage high demand fields such as offshore wind, advanced manufacturing, life sciences, technology etc. in an environment that respects, supports and develops emerging adults while facilitating learning.

In addition to the internship component of this request for proposals (RFP), a successful program will also incorporate a robust scholarship and financial literacy component. Financial literacy is the cognitive understanding of financial components and skills such as budgeting, investing, borrowing, taxation, and personal financial management.

Over 1.7 million individual scholarships are awarded annually. However, only 7% of college students will receive a scholarship. The U.S. Department of Education awards an estimated \$46 billion in scholarship money annually. A scholarship **allows students to focus on academics, increasing their chances of staying in school and graduating on time**. Students who receive scholarships have fewer financial concerns, more time to study, and a greater chance of success.

SECTION 3: Scope of Services

The City of Providence is soliciting proposals for a qualified entity to implement a youth Employer Based Internship and Scholarship Program that integrates best practices in education, workforce development, youth development and financial literacy. Through internships and scholarships, This provider will be tasked with administering a comprehensive internship & scholarship program that



connects Providence youth with nonprofit, private & public sector employers, preparing them for careers in high-wage, high-demand fields, equipping them with the tools needed to reach financial goals, in addition to providing financial assistance to college-bound high school seniors and other eligible residents who want to pursue post secondary education.

This provider must:

- Develop a program with the intention of meeting the recommendations of the <u>Reparations</u> <u>Commission Report.</u>
- Recruit, screen, train, and match youth with qualified nonprofit and private internship employers in high wage, high demand fields.
 - Employers must also include a financial literacy component within their internship program to support planning for post high-school graduation.
- Recruit, train and onboard Employer partners; providing a youth development focused training to staff responsible for supervising youth.
- Provide age-appropriate advanced work readiness training and financial literacy to all youth participants.
- Integrate youth development principles, job readiness and coaching, and financial literacy into work-based internship experiences for young people.
- Ensure participants are equipped with the tools & resources to reach financial goals
- Provide opportunities for youth to understand career pathways and decision points, including the linkages between educational attainment, relevant experience, demonstrable skills and career advancement.
- Include meaningful opportunities for youth leadership, reflection and growth on the larger personal and/or social impacts of their work.
- Disburse scholarship amounts, based on eligibility criteria, to respective students & youth
 - Scholarship disbursements must be determined by a specific and measurement data point/benchmark that indicates impact of scholarship (ex: how they plan to spend the money, tuition, loans, other expenses)

Program Requirements

A. Qualified Applicants

Qualified entities must have established and demonstrated experience administering a comprehensive and comparable internship & scholarship program for Black, Indigenous and other People of Color (BIPOC) and underserved youth. The following entities are eligible to apply.

- Established community-based organizations
- Private non-profit agencies/institutions
- Private for-profit companies
- Public agencies



• Educational institutions including a non-traditional public secondary school or career and technical education.

B. Period of Performance & Required Trainings

- The required period of performance of this RFP is January 2, 2023 to December 31st, 2024
- At the discretion of the City of Providence, services contracted under this RFP may be extended for additional periods based on availability of funds and program and provider performance.
- Providers are required to attend a 90-minute provider group meeting quarterly from December 2022 to December 2024.

C. Participant Eligibility

To be eligible to participate in the Internship & Scholarship Program, a student, youth or eligible resident of Providence, must meet at least one of the below qualifications:

- On a pathway towards high school graduation i.e (currently in high school or GED program)
- Be a resident of the City of Providence
- Be eligible to work in the United States
- Have a Work Permit in compliance with federal and state labor laws
- INDIGENOUS PEOPLE People who are a part of social and cultural groups that share collective ancestral ties before the European settlement of Providence and Rhode Island, including the natural resources where they live, inhabit, or from which they have been displaced.
- AFRICAN HERITAGE PEOPLE An ethnic group consisting of people with ancestry originating from sub-Saharan Africa. Today, the city's African heritage residents include, but are not limited to, African American, African, Bi-racial, Afro-Latino, Cape Verdean, and Afro-Caribbean.
- QUALIFIED CENSUS TRACTS & NEIGHBORHOODS Under the final U.S. Treasury ARPA rule, recipients of funding "were allowed to presume that families residing in Qualified Census Tracts (QCT) or receiving services provided by Tribal governments were disproportionately impacted by the pandemic." Providence QCTs eligible for these programs include Upper and Lower South Providence, Washington Park, Mount Hope (Lippitt Hill), Olneyville, Fox Point, Hartford, Elmwood, Smith Hill, Wanskuck, and Manton.
- RESIDENTS FACING POVERTY Providence residents/households earning less than 50% of the Area Median Income that are considered to be very low-income. Preference given to residents/households earning less than 30% of AMI who are considered to be extremely lowincome households.



D. Labor Laws

The selected program and all program activities must comply with applicable federal and state labor laws including child labor, OSHA, Right-To-Know, and ADA (i.e. hours, working conditions, use of equipment, etc.). It is the provider's responsibility to be aware of these regulations. OEO reserves the right to impose further restrictions on activities when determined to be appropriate. PROGRAM DESIGN

City of Providence Internship & Scholarship Program Design

The overarching goal of the City of Providence Internship & Scholarship Program is to provide youth with a set of work-related experiences that can better prepare them to succeed in employment, and to provide financial assistance to college-bound high school seniors or GED program participants who want to pursue post secondary education. *The Internship & Scholarship program* will:

- Offer developmentally appropriate experiences for youth and provide tiered work experiences that build skills, career exposure, and work readiness, year over year.
- Build social and emotional learning competencies tailored to the developmental needs of the target population and enhance employability options.
- Include internship and work-based learning experiences that compliment school-year academic and after school activities and programming.
- Offer a variety of skills based job training pathways that match the expertise of corporate, private and public partners.
- Provide financial assistance to college-bound high school seniors and other eligible residents who want to pursue post secondary education.
- Lessen the financial burden of pursuing a higher education.
- Reduce how much a student needs to pay for their higher education out of pocket.
- Ensure participants are instructed on methods to have the ability to make better financial decisions
- Offer a variety of skills based job training pathways that match the expertise of corporate, private and public partners.
- Provide youth with access to high-quality internships, advanced work-readiness and on the job training, financial literacy and career learning opportunities.



- Match youth with emerging industry and job sectors within the city and state including, but not limited to, offshore wind, advanced manufacturing, life sciences and technology.
- Capitalize the funds through matching gifts from partnering educational and charitable institutions.

PART A: Administrative Requirements

If selected as a provider through this RFP, you must:

- Have the financial capacity to pay program costs up front (including youth wages) and receive reimbursement upon submission of invoices with backup documentation.
- Refer all interested youth to the centralized application process and ensure submission of eligibility documentation and work permits.
- Attend training to use the Summer Program Management System chosen by OEO.
- Interview applicants and choose participants.
- Collect I-9 documentation for the youth selected for your program.
- Attend monthly provider meetings from May through September 2022.

PART B: Work Sites

Placement sites should enable participants to gain work maturity, occupational skills, and exposure to the working world. The assignment of a youth to a work site should be decided by balancing the needs of the participant and employer. A work placement may not be used to reduce current employee work hours or subsidize current employee wages.

- Employers committing to be a worksite must agree to:
 - Follow State and Federal Child Labor Laws http://www.dlt.ri.gov/ls/childlabor.htm
 - Sign a Worksite Agreement with the selected provider
 - Provide a meaningful work experience in which youth perform relevant work activities
 - Provide proper supervision and positive adult role models for youth
 - Fill out weekly timesheets for youth
 - Fill out an evaluation form at the midpoint and the end of the placement
- At Work Placement Sites, Worksite Supervisors (employer staff) must:
 - Attend a Worksite Orientation before youth arrival.
 - Comply with all portions of worksite documentation, safety practices and procedures and quality requirements.
 - Support youth in setting and maintaining realistic goals and expectations.



 Establish a safe learning environment including activities that promote developmentally appropriate experiences for youth and provide tiered work experiences that build skills, career exposure, and work readiness

PART C: Payments

- <u>Payments To Youth:</u> All youth will be paid for participation in the program via the provider's payroll. Stipend payments will be equal to the wage per hour and number of program hours per participant.
 - Through provider's payroll, at the 2022 minimum program wage of \$15.00/hr per hour, regardless of their age, for a maximum number of 120 hours per program slot.
 - Programs may propose to pay youth above the minimum wage, but under this RFP, the maximum reimbursement the provider may invoice for is \$15.00/hr per hour unless proposed payments above \$15.00/hr are approved.
 - Awarded programs must pay youth weekly or biweekly.
- **<u>Payment to Providers</u>**: Providers will be *reimbursed* in two payments, based on achievement of benchmarks and submission of invoice and documentation:

 - Submit final requisition for payment no later than December 31st, 2023
 - Types of Contracts and Payments:
 - Contracts will be issued on a benchmark basis. Budgets will be negotiated using the line-item format in the RFP.
 - The final program cost will be divided by the number of participants to determine the cost per participant. The first payment will be made based on the number of youth achieving the work readiness benchmark, and the second payment will be reimbursement based. In order for providers to invoice OEO for completion, each participant must complete at least 75% of planned program hours.
 - Under no circumstances will the Contractor receive reimbursement for any amount that exceeds the maximum contracted amount.
 - All invoices must include backup documentation of benchmarks and receipts for budgeted expenses. Awarded providers will receive a grantee guide with backup documentation requirements

PART D: Participant Recruitment and Application



Selected providers will be required to:

- Take part in an individual or centralized review and selection process for program enrollment in collaboration with the Mayor's Office.
- Direct interested youth to complete an application through an individual or centralized portal and rank program offerings in terms of interest in
- Recruit/enroll participants beyond those youth they currently serve.
- Interview and enroll youth applicants/participants.
- Submit reports. *OEO will provide the reporting forms for programs to update online.* Reports may include but are not limited to:
 - Pre-and post-test and survey findings for all participants.
 - Weekly Wage Reports that document the hours and wages youth have earned
 - Incident Report Form (if needed)
 - Final Report Due June 30th, 2024
 - Follow-Up Report of Post-Program Activity December 2024 (if known)

PART E: Maintenance of Effort and Stand Alone

Contractor shall comply with Executive Order 11246, "Equal Employment Opportunity," as amended by EO 11375, "Amending Executive Order 11246 Relating to Equal Employment Opportunity," and as supplemented by regulations at 41 CFR part 60, "Office of Federal Contract Compliance Programs, Equal Employment Opportunity, Department of Labor."

2. Minority and Women Business Enterprises (if applicable to this Contract)

Contractor hereby agrees to comply with the following when applicable: The requirements of Executive Orders 11625 and 12432 (concerning Minority Business Enterprise), and 12138 (concerning Women's Business Enterprise), when applicable. Accordingly, the Contractor hereby agrees to take affirmative steps to assure that women and minority businesses are utilized when possible as sources of supplies, equipment, construction, and services. Affirmative steps shall include the following:

a) Including qualified women's business enterprises and small and minority businesses on solicitation lists;

4. Byrd Anti-Lobbying Amendment, 31 U.S.C. § 1352, as amended. (Applies to all purchases.)

Contractor certifies that it will not and has not used Federal appropriated funds to pay any person or organization for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, officer or employee of Congress, or an employee of a Member of Congress in connection with obtaining any Federal contract, grant, or any other award covered by 31 U.S.C. § 1352. Contractor shall also disclose any lobbying with non-Federal funds that takes place in connection with obtaining any Federal award. Such disclosures are forwarded from tier to tier up to the recipient who in turn will forward the certification(s) to the awarding agency.

5. Access to Records. (Applies to all purchases.)

The Contractor agrees to permit any of the foregoing parties to reproduce by any means or to copy excerpts and transcriptions as reasonably needed and agrees to cooperate with all such requests.

B. The Contractor agrees to provide the Treasury Department or authorized representatives access to construction or other work sites pertaining to the work being completed under the contract.

C. No language in this contract is intended to prohibit audits or internal reviews by the Treasury Department or the Comptroller General of the United States.

6. Rights to Inventions Made Under a Contract or Agreement.

Contracts or agreements for the performance of experimental, developmental, or research work shall provide for the rights of the Federal Government and the recipient in any resulting invention in accordance with 37 CFR part 401,



"Rights to Inventions Made by Nonprofit Organizations and Small Business Firms Under Government Grants, Contracts and Cooperative Agreements," and any applicable implementing regulations.

7. Contract Work Hours and Safety Standards Act (40 U.S.C. 327 through 333) (applies only to purchases over \$100,000, when laborers or mechanics are used.)

Where applicable, all contracts in excess of \$100,000 that involve the employment of mechanics or laborers shall include a provision for compliance with 40 U.S.C. 3702 and 3704 of the Contract Work Hours and Safety Standards Act, as supplemented by Department of Labor regulations (29 CFR part 5). Under Section 3702 of the Act, each contractor shall be required to compute the wages of every mechanic and laborer on the basis of a standard workweek of 40 hours. E. Contractor agrees to include these requirements in each subcontract exceeding \$150,000 financed in whole or in part with Federal assistance.

9. Prohibition on certain telecommunications and video surveillance services or equipment (Huawei and ZTE)

CITY OF PROVIDENCE STANDARD TERMS & CONDITIONS

- 1. The terms "you" and "your" contained herein refer to the person or entity that is a party to the agreement with the City of Providence ("the City") and to such person's or entity's employees, officers, and agents.
- 2. The Request For Proposals ("RFP") and these Standard Terms and Conditions together constitute the entire agreement of the parties ("the Agreement") with regard to any and all matters. By your submission of a bid proposal or response to the City's RFP, you accept these Standard Terms & Conditions and agree that they supersede any conflicting provisions provided by bid or in any terms and conditions contained or linked within a bid and/or response. Changes in the terms and conditions of the Agreement, or the scope of work thereunder, may only be made by a writing signed by the parties.
- 3. You are an independent contractor and in no way does this Agreement render you an employee or agent of the City or entitle you to fringe benefits, workers' compensation, pension obligations, retirement or any other employment benefits. The City shall not deduct federal or state income taxes, social security or Medicare withholdings, or any other taxes required to be deducted by an employer, and this is your responsibility to yourself and your employees and agents.
- 4. You shall not assign your rights and obligations under this Agreement without the prior written consent of the City. Any assignment without prior written consent of the City shall be voidable at the election of the City. The City retains the right to refuse any and all assignments in the City's sole and absolute discretion.
- 5. Invoices submitted to the City shall be payable sixty (60) days from the time of receipt by the City. Invoices shall include support documentation necessary to evidence completion of the work being invoiced. The City may request any other reasonable documentation in support of an invoice. The time for payment shall not commence, and invoices shall not be processed for payment, until you provide reasonably sufficient support documentation. In no circumstances shall the City be obligated to pay or shall you be entitled to receive interest on any overdue invoice or payment. In no circumstances shall the City be obligated to

pay any costs associated with your collection of an outstanding invoice.

- 6. For contracts involving construction, alteration, and/or repair work, the provisions of applicable state labor law concerning payment of prevailing wage rates (R.I. Gen. Laws §§ 37-13-1 et seq., as amended) and the City's First Source Ordinance (Providence Code of Ordinances §§ 21-91 et seq., as amended) apply.
- 7. With regard to any issues, claims, or controversies that may arise under this Agreement, the City shall not be required to submit to dispute resolution or mandatory/binding arbitration. Nothing prevents the parties from mutually agreeing to settle any disputes using mediation or non-binding arbitration.
- 8. To the fullest extent permitted by law, you shall indemnify, defend, and hold harmless the City, its employees, officers, agents, and assigns from and against any and all claims, damages, losses, allegations, demands, actions, causes of action, suits, obligations, fines, penalties, judgments, liabilities, costs and expenses, including but not limited to attorneys' fees, of any nature whatsoever arising out of, in connection with, or resulting from the performance of the work provided in the Agreement.
- 9. You shall maintain throughout the term of this Agreement the insurance coverage that is required by the RFP or, if none is required in the RFP, insurance coverage that is considered in your industry to be commercially reasonable, and you agree to name the City as an additional insured on your general liability policy and on any umbrella policy you carry.
- 10. The City shall not subject itself to any contractual limitations on liability. The City shall have the time permitted within the applicable statute of limitations, and no less, to bring or assert any and all causes of action, suits, claims or demands the City may have arising out of, in connection with, or resulting from the performance of the work provided in the Agreement, and in no event does the City agree to limit your liability to the price of the Agreement or any other monetary limit.
- The City may terminate this Agreement upon five
 (5) days' written notice to you if you fail to observe any of the terms and conditions of this Agreement, or if the City believes your ability to perform the



terms and conditions of this Agreement has been materially impaired in any way, including but in no way limited to loss of insurance coverage, lapsing of a surety bond, if required, declaration of bankruptcy, or appointment of a receiver. In the event of termination by the City, you shall be entitled to just and equitable compensation for any satisfactory work completed and expenses incurred up to the date of termination.

- 12. Written notice hereunder shall be deemed to have been duly served if delivered in person to the individual or member of the firm or entity or to an officer of the entity for whom it was intended, or if delivered at or sent by registered or certified mail to the last business address known by the party providing notice.
- 13. In no event shall the Agreement automatically renew or be extended without a writing signed by the parties.
- 14. You agree that products produced or resulting from the performance of the Agreement are the sole property of the City and may not be used by you without the express written permission of the City.
- 15. For any Agreement involving the sharing or exchange of data involving potentially confidential and/or personal information, you shall comply with any and all state and/or federal laws or regulations applicable to confidential and/or personal information you receive from the City, including but not limited to the Rhode Island Identity Theft Protection Act, R.I. Gen. Laws § 11-49.3-1, during the term of the Agreement. You shall implement and maintain appropriate physical, technical, and administrative security measures for the protection of, and to prevent access to, use, or disclosure of, confidential and/or personal information. In the event of a breach of such information, you shall notify the City of such breach immediately, but in no event later than twenty-four (24) hours after discovery of such breach.
- 16. The Agreement is governed by the laws of the State of Rhode Island. You expressly submit yourself to and agree that any and all actions arising out of, in connection with, or resulting from the performance of the Agreement or relationship between the parties shall occur solely in the venue and jurisdiction of the State of Rhode Island or the federal court located in Rhode Island.
- 17. The failure of the City to require performance of any provision shall not affect the City's right to

require performance at any time thereafter, nor shall a waiver of any breach or default of this Agreement constitute a waiver of any subsequent breach or default or a waiver of the provision itself.

18. If any term or provision of this Agreement, or the application thereof to any person or circumstance shall, in any extent, be invalid or unenforceable, the remainder of this Agreement shall not be affected thereby, and each term and provision shall be valid and enforceable to the fullest extent permitted by law.
