"(Item 1A) Lead Service Line Replacement – Public Side Only - Measurement will be based on the number of installations completed from the water main to the curb stop within the Work Area and shall be contingent on the submission of comparable pre-construction and post-construction photographs of each installation and complete record documents, including all permits, for each property. When only a public side only replacement (i.e., from water main to curb stop) is completed at a property, the Contractor shall be paid under Item 1A. Replacement includes all road opening permit acquisition and fees, piping, curb stop valve and box, new corporation stop, appurtenances to make all connections, procurement and placement of warning tape, flushing at the meter, pressure testing, and temporary sidewalk and/or yard restoration. Full Replacements will not be paid for under this item."

8. **SECTION 01025 – MEASUREMENT AND PAYMENT:** On Page 01025-6, **REPLACE** Article 3.01 Paragraph B.2 with the following revised Paragraph B.2:

"(Item 1B) Lead Service Line Replacement – Public Side Portion of a Full Replacement - Measurement will be based on the number of installations completed from the water main to the curb stop within the Work Area, only where the private side of the service line is also being replaced (full replacement) and shall be contingent on the submission of comparable pre-construction and post-construction photographs of each installation and complete record documents, including all permits, for each property. Replacement includes all road opening permit acquisition and fees, piping, curb stop valve and box, procurement and placement of warning tape, and appurtenances to make all connections. Full Replacements performed under this contract within the Work Area will be paid for as the sum of Item 1B and Item 2B."

9. **SECTION 01025 – MEASUREMENT AND PAYMENT:** On Page 01025-6, <u>ADD</u> the following sentence to the end of Article 3.01 Paragraph B.3:

"Temporary sidewalk and/or yard restoration shall be included in this Item."

10. **SECTION 01025 – MEASUREMENT AND PAYMENT:** On Page 01025-6, **REPLACE** Article 3.01 Paragraph B.5 with the following revised Paragraph B.5:

"(Item 1D) Long-Side Replacement – Measurement will be based on the number of long-side replacements. A long-side replacement is when the resident with the service line being replaced is on the opposite side of the street from the water main. The distance from the water main to the curb must be greater than half the roadway width for a replacement to be considered a long side replacement. Water mains down the center of the road do not have long-side replacements on either side and will not be measured under this item. This Item will be paid in addition to either Bid Item 1A or Bid Item 1B to cover the cost of the additional time and material for the additional length of service line required to be replaced."

11. **SECTION 01025 – MEASUREMENT AND PAYMENT:** On Page 01025-6, **REPLACE** Article 3.01 Paragraph B.6 with the following revised Paragraph B.6:

"(Item 1E) Lead Service Line Excavation Greater Than 5 Feet – Measurement will be based on the actual depth of excavation beyond a 5-foot depth, as approved by the Engineer, for a maximum trench width as shown in Details, if and when directed. If the trench bottom is more than twelve inches below pipe invert through an error by the Contractor or if improper drainage softens the subgrade and additional excavation in the trench or access pit is required before laying the pipe or installing the water service line, such removal and replacement of material will not be paid for by Owner. Measurement by truck count will not be permitted."

- 12. **SECTION 01025 MEASUREMENT AND PAYMENT:** On Page 01025-7, **REPLACE** Article 3.01 Paragraph C.1.a with the following revised Paragraph C.1.a:
  - "a. **Administration:** Price and payment shall include, but not be limited to customer coordination, printing and distributing door hangers for notifications of service disturbance, procurement and posting of no parking signs, local agency coordination for permits, permit fees, inspections and scheduling; pipe material validation through interior inspection; underground utility mark outs and coordination, pre-construction photographs; and all other preliminary documentation as required by the Contract."
- 13. **SECTION 01025 MEASUREMENT AND PAYMENT:** On Page 01025-7, **REPLACE** Article 3.01 Paragraph C.1.d with the following revised Paragraph C.1.d:

- "d. *Restoration on Public Side:* Price and payment shall include, but not be limited to temporary traffic control including traffic signage and flagger; GPS coordinates, service application records, closeout documentation including photographs; repairs and cleaning of interior work spaces; procurement and placement of warning tape, restoring exterior physical features; temporary sidewalk and/or yard restoration; forming and pouring concrete curbs, concrete testing and all other testing required to complete the project as specified herein; transportation and disposal of excess excavated material, spoil, rubble, concrete, asphalt, vegetation, lead pipes and construction debris, etc. in accordance with all Federal, State and local regulations; including all labor, materials and necessary equipment; removal of erosion and sediment control; all work required for or incidental to the satisfactory completion of the Items for which payment is not provided under other items in the Bid Form."
- 14. **SECTION 01025 MEASUREMENT AND PAYMENT:** On Page 01025-8, **REPLACE** Article 3.01 Paragraph C.2 with the following revised Paragraph C.2:
  - "2. Payment for Item 1C, Test Pit at Curb Stop, shall be made as follows: Payment for this Item shall be provided for the Contractor completing 3.01-C.1a Administration, 3.01-C.1b Site Preparation, performing the test pit, and 3.01-C.1d. Test pit shall assume excavation is in concrete and temporary sidewalk restoration is included in this bid item. Payment for Item 1C will only be made if the entire water service line (corporation stop to meter) is found not to be lead. No payment will be made under this Item if any pipe replacement is performed. If the curb box is replaced without a portion of the service line being replaced, payment will be made under Item 1C plus Item 2C for the curb box. Contractor will not receive payment for Item 2C if the curb box is damaged during excavation."
- 15. **SECTION 01025 MEASUREMENT AND PAYMENT:** On Page 01025-10, **REPLACE** Article 3.03 Paragraph A.1.a with the following revised Paragraph A.1.a:
  - "a. Trenchless or other approved means of lead water service line replacement which may include, replacement of the private side only service line (Item 2A), replacement of the private side portion of a full replacement (Item 2B), and replacing, furnishing and installing all required ball valves, adapters, reducers, fittings, flare adapters (before and after water meter), pressure reducing valves (after main isolation and before water meter), backflow devices (after water meter), expansion tanks (after backflow device), reduced pressure zone (RPZ) backflow preventers (if required), and appurtenances of the necessary size required and as required by Rhode Island Plumbing Code. All replacements, full or private side only, shall include mobilization (sanitary facilities, insurance, temporary construction facilities, construction vehicle parking and storage, drywall restoration, bonds, permit acquisition and fees, labor, project coordination, control of work, project signs, coordination with

homeowner, property residents, tenants, and inspectors, scheduling, notifications, printing, all data and record document management, and preparation of contract required submittals); removal and disposal excess soil, spoil, rubble, lead pipes and construction debris, vegetation and similar items; stockpiling, providing for an on-site technician from the Soils Testing Laboratory for at least 10 days of the project work, sampling and testing; temporary sidewalk and/or yard restoration; all work required for or incidental to the satisfactory completion of the Work."

16. **SECTION 01025 – MEASUREMENT AND PAYMENT:** On Page 01025-10, **REPLACE**Article 3.03 Paragraph B.1 with the following revised Paragraph B.1:

"(Item 2A) Lead Service Line Replacement – Private Side Only - Measurement will be based on the number of installations completed from the curb stop to water meter within the Work Area and shall be contingent on the submission of comparable pre-construction and post-construction photographs of each installation and complete record documents, including any required permits, for each property. When a private side only replacement (i.e., from curb stop to water meter) is completed at a property, the Contractor shall be paid under Item 2A. Replacement includes scheduling all service line replacement appointments with homeowner, residents, or tenants, plumbing permit acquisition and fees, piping, coring and patching through wall or floor, drywall restoration, one ball valve (or one on each side of meter if directed by Owner or Engineer due to a meter replacement), appurtenances to make all connections as listed in A above, procurement and placement of warning tape, temporary sidewalk and/or yard restoration, flushing at the meter, pressure testing, equipment required for erosion and sediment control, and protection of existing. New curb boxes for private side only replacements will be paid under Item 2C as directed by the Engineer. Full Replacements will not be paid for under this item."

17. **SECTION 01025 – MEASUREMENT AND PAYMENT:** On Page 01025-11, **REPLACE** Article 3.03 Paragraph B.2 with the following revised Paragraph B.2:

"(Item 2B) Lead Service Line Replacement – Private Side Portion of a Full Replacement - Measurement will be based on the number of installations completed from the curb stop to water meter within the Work Area only where the public side installation is also being replaced (full replacement) and shall be contingent on the submission of comparable preconstruction and post-construction photographs of each installation and complete record documents, including any required permits, for each property. Replacement includes scheduling all service line replacement appointments with homeowner, plumbing permit acquisition and fees, piping, coring and patching through wall or floor, drywall restoration, one ball valve (or one on each side of meter if directed by Owner or Engineer due to a meter replacement), temporary sidewalk and/or yard restoration, appurtenances to make all

  - "3. (Item 2C) New Curb Box Measurement will be based on the number of curb boxes replaced at the direction of the Engineer for private-side only replacements (Item 2A) and curb boxes replaced during a test pit (Item 1C) at the direction of the Engineer. Curb box and valve replacement is already included in Items 1A and 1B for public side replacements."
- 19. **SECTION 01025 MEASUREMENT AND PAYMENT:** On Page 01025-11, **REPLACE** Article 3.03 Paragraph C.1.a with the following revised Paragraph C.1.a:
  - "Administration: Price and payment shall include, but not be limited to customer coordination, printing and distributing door hangers notifications of service disturbance, procurement and posting of no parking signs, local agency coordination and all preparation, submittal and fees associated with permits, inspections and scheduling; pipe material validation through interior inspection; underground utility mark outs and coordination, preconstruction photographs; and all other preliminary documentation as required by the Contract."
- 20. **SECTION 01025 MEASUREMENT AND PAYMENT:** On Page 01025-11, **REPLACE** Article 3.03 Paragraph C.1.c with the following revised Paragraph C.1.c:
  - "Service Replacement: Price and payment shall include, but not be limited to: temporary traffic control including traffic signage and flagger; temporary water for customer (as required); furnishing and installation of water service line (up to and including 2-inches in size) to limits defined in individual bid items by trenchless methods or by open-cut methods when approved by the Engineer, including pipe, all the necessary adapters, reducers, fittings and appurtenances of the necessary size required to connect to existing piping; coring through the existing foundation or wall, flushing, testing of the new service line, placing the service line into service; existing lead water service line and appurtenances demolition or abandonment; procurement and placement of warning tape, backfill materials as shown in Appendix B; compaction; restoring the trench surface to grade; stockpiling. Payment for these items shall include all work required for or incidental to the satisfactory completion of the Items for which payment is not provided under other items in the Bid Form."

- 21. **SECTION 01025 MEASUREMENT AND PAYMENT:** On Page 01025-12, **REPLACE**Article 3.04 Paragraph A.1.a with the following revised Paragraph A.1.a:
  - "a. Trenchless or other approved means of lead water service line replacement which may include, replacement of the private side only service line at a commercial property (Item 3A), replacement of the private side portion of a full replacement at a commercial property (Item 3B), and replacing, furnishing and installing all required ball valves, adapters, reducers, fittings, flare adapters (before and after water meter), pressure reducing valves (after main isolation and before water meter), backflow devices (after water meter), expansion tanks (after backflow device), reduced pressure zone (RPZ) backflow preventers (if required), procurement and placement of warning tape, and appurtenances of the necessary size required and as required by Rhode Island Plumbing Code. All replacements, full or private side only, shall include mobilization (sanitary facilities, insurance, temporary construction facilities, construction vehicle parking and storage, bonds, permit acquisition and fees, labor, project coordination, control of work, project signs, coordination with property owner and inspectors, scheduling, notifications, printing, all data and record document management, and preparation of contract required submittals); removal and disposal of excess soil, spoil, rubble, lead pipes and construction debris, vegetation and similar items; stockpiling, equipment required for erosion and sediment control, protection of existing trees and replacement or healing treatment of all trees as approved by the Engineer, providing for an on-site technician from the Soils Testing Laboratory at all locations for at least 10 days of project work, sampling and testing; temporary sidewalk and/or yard restoration; all work required for or incidental to the satisfactory completion of the Work."

  - "a. **Administration:** Price and payment shall include, but not be limited to customer coordination, printing and distributing door hangers for notifications of service disturbance, procurement and posting of no parking signs, local agency coordination, any preparation, submittal, and fees associated with permitting, inspections and scheduling; pipe material validation through interior inspection or test pit; underground utility mark outs and coordination, pre-construction photographs; and all other preliminary documentation as required by the Contract."

#### WRITTEN QUESTIONS AND COMMENTS SUBMITTED

All questions asked during the pre-bid conference meeting are documented with responses provided in the pre-bid conference meeting report that is included with this Addendum. The following additional questions were also received:

1. QUESTION: The specification states that no sidewalk permits will be issued in the winter. Can we still work through the winter or is work not allowed during the winter months?

**RESPONSE:** No Providence Department of Public Works controlled roads can be opened after November 15<sup>th</sup> or before April 15<sup>th</sup> as stated in Section 02576 Article 3.01 Paragraph A.2. All necessary permits must be obtained for work to occur.

**2. QUESTION**: How many calendar days do we have to complete the project? Are there any liquidated damages? When would you like the contractor to start and finish the project?

**RESPONSE:** Road opening and sidewalk permits are typically issued from April 15th through November 15th by the City of Providence. The completion date in Section 00 52 00 has been updated by this Addendum to August 15<sup>th</sup>, 2023. Refer to Sections 00 61 13.13 and 00 72 00 for liquidated damages.

**3. QUESTION:** If the homeowner declines a customer side lead service replacement, will the public side service still be replaced at that location?

**RESPONSE:** No, this is defined as a partial replacement in Section 01010 1.01B. No partial replacements are allowed.

**4. QUESTION:** How many lead services will be replaced, what is the individual footage? What is the diameter?

**RESPONSE:** Refer to Appendix A.

#### 2. Summary of Project and Work

Trinity Square Lead Service Line Replacement Program Project No. 27002 & 20173

- a. The Work of this Project generally includes replacing lead service lines within the retail water service area of PW in the Trinity Square area of the City of Providence, Rhode Island.
- Work of this Project will include, but is not limited to, furnishing all materials, labor, equipment, tools, services, appurtenances, and incidentals required to replace lead service lines (both public and private) and to perform all required and associated surface restoration.
- c. Refer to Section 01010 Summary of Work for a detailed description and summary of all Work of this Project.
- d. Bidders are requested to provide unit rate bid prices for replacing public side only lead service lines (water main to curb stop), public side portion of a full lead service line (water main to curb stop), private side only lead service line (curb stop to meter) and private side portion of a full lead service line (curb stop to meter), along with their qualifications to perform the Work of replacing water service lines. Minimum qualification requirements for water service line replacements and installations are specified in Section 00 21 13 Instructions to Bidders, Article 2, Paragraph 2.2.
- e. The intent of this Project is that the Owner desires to make an award to the lowest qualified and responsible Bidder on the basis of the Base Bid plus all Supplementary Bid Items.
- f. No work shall be performed by any Contractor without first obtaining and securing proper permits from the respective jurisdiction(s) and issuing authorities. Permit costs are to be included as part of the lead service line replacement unit cost.
- g. Uniformed Traffic Control, if needed or required, shall be arranged and coordinated directly by the Contractor and invoices for any and all traffic control shall be submitted separately for direct reimbursement with no markup by Contractor under the allowance item as included Bid Item No. 1I.
- h. Refer to Section 01025 Measurement and Payment for a detailed description of the various items of the work. Lead service line replacements shall be the same price and payment for each and every lead service line replacement of that replacement item type.
- i. All Work shall be constructed in accordance with PW's Specifications and Construction Details. If there are any conflicts between these technical specifications and construction details, specifically in the General Requirements of these appended documents, the Division 0 and Division 1 of these Specifications shall govern.

#### 3. General

2. Question: Completion date is May 3<sup>rd</sup>? Will there be any issue getting permits through the winter months?

Answer: Road opening and sidewalk permits are typically issued from April 15<sup>th</sup> through November 15<sup>th</sup> by the City of Providence. Please refer to Addendum No. 1 for revised schedule.

3. Question: Do we know what roads have concrete road base?

- 4. Question: If you use the excavation for construction, then you don't get paid for test pit. If you use the excavation and the service is copper on both private and public side, you get paid for test pit. Is that correct?

Test pits are defined in Section 01025 3.01 A.2.a as "a planned service line replacement that is found not to be lead on either side or a property where the Owner or Engineer specifically directs the Contractor to perform a test pit." If a replacement ensues, Contractor is paid for the replacement item related to the work.

5. Question: Mill and overlay, some of the streets have one service, some of them have twenty-one services on it, what's the rule of thumb for where you start and stop the milling and overlaying? Are we to mill and overlay curb to curb, block to block or just where the services are done.

Answer: Paving requirements are dependent on if the street is included in the City paving project, is under moratorium, and/or the number/distance between

6. Question: Police and flaggers, it has been my experience with Providence Water that we try to get police and if they can't be filled then use flaggers. Is that the same thing now, if you call the police and they can't come for whatever reason, I'll call flaggers. Are flaggers included in the allowance?

Answer: Flaggers, if needed, are included in other pay items. See Section 01025. The Uniformed Traffic Control Allowance (Item 1I) shall be for traffic control police officers only.

7. Question: Providence Water has a pitcher filter distribution program noted in 1.05B of the Section. Does that involve the contractor at all?

Answer: This is for Contractor information only and to be performed by the Owner.

8. Question: Steel road plates countersunk and minimum four pins securing it is included in 1.06D in Section 01010. I assume that is for winter months. I don't think we have ever secured road plates before.

Answer: Steel road plates shall be provided as specified in Section 01010.

9. Question: Work season is from March to November; one note says the contract goes through 5/3/23. That is impossible to do the job in that timeframe. Job can't start until March or April when winter is over it is not practical to complete.

Answer: Refer to answer on Question 2.

10. Question: Don't you need a permit for sidewalk opening? What is the cost?

Answer: Permits are the responsibility of the Contractor as specified and shall be included in Bid Items 1A, 1B, 1C, 2A, 2B, 3A and 3B. Contact Providence DPW for costs of permits.

11. Question: Why is there mill and overlay if there is a paving program?

Answer: The City of Providence paving program for this area does not include all streets. Final road restoration is required on streets not included in the City's upcoming paving program. Refer to Appendix C.

12. Question: Can we get a list of streets that are included in the paving program.

Additional replacements are included in the bid form to account for any unknown replacements that may be encountered or identified that are not listed in Appendix A. As specified in Section 01010 Paragraph 1.01B. Providence Water reserves the right to add or delete replacements listed in Appendix A.

14. Question: Commercial replacements, private sides, I don't see commercial on public side. It doesn't match up.

Answer: Private side commercial property owners are tracked separately from private side residential property owners. Public side (Bid Item 1B) on both the commercial and residential properties are not tracked separately.

15. Question: Private side customers, have they already signed up for this work to be done? And do they get back charged or who pays for it.

Answer: Providence Water is obtaining the customer agreements for private side replacements in accordance with 01014 Paragraph 1.08.A.6.

16. Question: You don't have a bid item for reinforced concrete paving.

Answer: Bid Item S-2A includes concrete subbase.

17. Question: There should be an item for sidewalk replacement. There always has been in the past.

Answer: Temporary sidewalk restoration is required under the lead service line replacement items as specified in Section 01025 3.01B.1 and 3.01B.2. Final sidewalk restoration will be completed as part of the City paving project and not as part of this project.

18. Question: I am not sure we can even do the private side without permission from the DPW. I brought this to their attention, and they are pretty adamant on us getting off the street, sidewalk, anything by that date. They were ready to shut us down for just private sides on November 15 and just extended it to December 3

Answer: Refer to answer on Question 2.


