2. Part I, section 1.1.C.3 (Page I-10 and I-11) – Remove the entire item.
3. Part I, section 1.2 (Page I-12) – Remove the following text – *“The Proposer shall provide rates for the requested positions:”*
4. Part I, section 1.2 (Page I-15) – Remove the following text – *“Work for out-of-category discipline work performed will be compensated at the same rates and positions proposed by the firm for its awarded category.”*
5. Part I, section 1.2 (Page I-15) – Remove the following text – *“Hourly rates used for invoicing these projects will be those quoted by the Proposer on the "Bidder's Blank Attachment", and no adjustment for changes in rates will be allowed should the project run into the next fiscal year of the Proposer, with the exception of years 4, and 5 should PW extend the Consulting Services Blanket.”*
6. Part I, section 1.3 Section 3 – FEE (Page I-16 and I-17) – Remove Entire Item.
7. Part I, section 1.4 (Page I-17) – Remove the following text – *“The evaluation and award method utilized by Providence Water will place a 80% emphasis on qualifications and 20% emphasis on price.”*
8. Part I, section 1.14 (Page I-19) – Remove entire section.
9. Part I, section 1.15.A.1 (Page I-19) – Remove the following text – *“Payments will be made based on the fixed hourly rate(s) quoted in the proposal and”*
10. Part I, section 1.15.A.1 (Page I-19) – Remove the following text – *“(as provided in the successful Proposer’s schedule of fees)”*
11. Bidder’s Blank Attachment – Delete this section.
