NOTICE TO VENDORS

- 1. The Board of Contract and Supply will make the award to the lowest qualified and responsible bidder(s).
- 2. In determining the lowest responsible bidder(s), cash discounts based on preferable payment terms will not be considered.
- 3. Where prices are the same, the Board of Contract and Supply reserves the right to award to one bidder, or to split the award.
- 4. No proposal will be accepted if the bid is made in collusion with any other bidder.
- 5. Bids may be submitted on an "equal in quality" basis. The City reserves the right to decide equality. Bidders must indicate brand or the make being offered and submit detailed specifications if other than brand requested.
- 6. A bidder who is an out-of-state corporation shall qualify or register to transact business in this State, in accordance with the Rhode Island Business Corporation Act, RIGL Sec. 7-1.2-1401, et seq.
- 7. The Board of Contract and Supply reserves the right to reject any and all bids.
- 8. Competing bids may be viewed in person at the Department of the City Clerk, City Hall, Providence, immediately upon the conclusion of the formal Board of Contract and Supply meeting during which the bids were unsealed/opened. Bids may also be accessed electronically on the internet via the City's Open Meetings Portal.
- 9. As the City of Providence is exempt from the payment of Federal Excise Taxes and Rhode Island Sales Tax, prices quoted are not to include these taxes.
- 10. In case of error in the extension of prices quoted, the unit price will govern.
- 11. The contractor will **NOT** be permitted to: a) assign or underlet the contract, or b) assign either legally or equitably any monies or any claim thereto without the previous written consent of the City Purchasing Director.
- 12. Delivery dates must be shown in the bid. If no delivery date is specified, it will be assumed that an immediate delivery from stock will be made.
- 13. A certificate of insurance will normally be required of a successful vendor.
- 14. For many contracts involving construction, alteration and/or repair work, State law provisions concerning payment of prevailing wage rates apply (<u>RIGL Sec. 37-13-1 et seq.</u>)
- 15. No goods should be delivered, or work started without a Purchase Order.
- 16. Submit 2 copies of the bid to the City Clerk, unless the specification section of this document indicates otherwise.
- 17. Bidder must certify that it does not unlawfully discriminate on the basis of race, color, national origin, gender, gender identity or expression, sexual orientation and/or religion in its business and hiring practices and that all of its employees are lawfully employed under all applicable federal, state and local laws, rules and regulations. 1.	Financial assurances may be required in order to be a successful bidder for Commodity or Construction and Service contracts. - unless qualified otherwise. Requests for price increases will not be honored.
- 3. Failure to deliver within the time quoted or failure to meet specifications may result in default in accordance with the general specifications. It is agreed that deliveries and/or completion are subject to strikes, lockouts, accidents, and Acts of God.

WBE/MBE Form Instructions

The City of Providence actively seeks Minority and Women business enterprises to participate in bids to meet the City's procurement needs. Pursuant to the City of Providence Code of Ordinances, Chapter 21, Article II, Sec. 21-52 (Minority and Women's Business Enterprise) and Rhode Island General Laws (as amended), Chapter 37-14, et seq. (Minority Business Enterprise), Minority Business Enterprise (MBE) and Women's Business Enterprise (WBE) participation goals apply to contracts.

The goal for Minority Business Enterprise (MBE) participation is **10%** of the total bid value. The goal for Women's Business Enterprise (WBE) participation is **10%** of the total bid value. The goal for combined MBE/WBE participation is **20%** of the total bid value.

<u>Only businesses certified with the State of Rhode Island</u> as minority and/or women business enterprises are counted towards the City's goals. Eligible minority or women-owned businesses are encouraged to seek certification from the State of Rhode Island Minority Business Enterprise Compliance Office at: https://dedi.ri.gov/divisions-units/minority-business-enterprise-compliance-office

Note: MBE certification with the State of Rhode Island on the basis of Portuguese heritage is not currently recognized by the City of Providence's MBE program.

Bid Requirements:

- 1. All Bidders: All bidders must complete and submit the MBE/WBE Participation Affidavit (page 13) indicating whether or not they are a state-certified MBE/WBE and acknowledging the City's participation goals. Submission of this form is required with every bid. Your bid will not be accepted without an affidavit.
- 2. Bidders who will be subcontracting: In addition to the MBE/WBE Participation Affidavit, Bidders who will be subcontracting must submit the Subcontractor Disclosure Form as part of their bid submission. All subcontractors, regardless of MBE/WBE status, must be listed on this form. Business NAICS codes can be found at https://www.naics.com/search/. Awarded bidders are required to submit Subcontractor Utilization and Payment Reports with each invoice.

3. Waiver Requests:

- a) If the percentage of the total amount of the bid being awarded to MBE or WBE vendors is less than 20% (Box F on the Subcontractor Disclosure Form) and the prime contractor is not a Rhode Island State-certified MBE or WBE, the Bidder must complete the MBE/WBE Waiver Request Form (page 14) and obtain approvals prior to bid submission.
- b) If the prime contractor company has the capacity to perform the whole project, the City of Providence requires the contractor to complete the MBE/WBE Waiver Request Form (page 14) and obtain approvals prior to bid submission.
- c) If the contractor is a nonprofit organization, they are not required to complete the *MBE/WBE Waiver Request Form*. However, the City of Providence requires the nonprofit organization to provide the *MBE/WBE Participation Affidavit Form* and proof of its nonprofit status.
- d) If the contractor has researched the RI Certified minority list (https://dedi.ri.gov/divisions-units/minority-business-enterprise-mbe) and the state does not have any companies in the desired trade, the contractor must complete the MBE/WBE Waiver Request Form (page 14) and obtain approvals prior to bid submission.
- e) Waivers will be considered for approval on a case-by-case basis.

The form must include all subcontractors utilized on the contract, both MBE/WBE and non- MBE/WBE, the total amount paid to each subcontractor for the given period and to date, A copy of all forms should be sent to the MBE/WBE Outreach Director Office, Grace Diaz at gdiaz@providenceri.gov. During the term of the contract, any unjustified failure to comply with the MBE/WBE participation requirements is a material breach of contract.

BID PACKAGE SPECIFICATIONS

Background Information

The purpose of this solicitation is to establish a contract for the purchase of Safety Shoes and Boots to meet the City's needs on an as-needed basis.

Scope of Work

The award of this contract will be made to the responsible bidder who meets the criteria listed below and who offer the highest percentage discount off the manufacturer's latest published price list or catalog.

Term of the Contract

The initial term of this contract is expected to commence the day succeeding the approval of the contract by the Board of Contract and Supply contingent upon the completion and submittal of all required bid documents and the full execution of a contract. The contract shall remain effective for one year. The contract can be renewed for two one-year periods. Each renewal period will require approval of both parties.

Vendor Qualifications

The bidder must submit its manufacturer's price list or catalog with its bid proposal to be considered for award. The price list must be common to and accepted by the industry in general.

The City will purchase safety shoes on an as-needed basis. Due to the nature of this contract, the bidder must be located (have a business address) within 15 miles radius of city center or be able to provide a Mobile Unit equipped with personnel capable of fitting and sizing the employees for various styles of shoes and boots and provide for pick-up of special orders as required. Submit a detailed list of mobile unit(s) and/or facilities used to provide services, inclusive of days and hours of operations.

With the exception of increases to the discount awarded, the percentage discount shall be fixed and firm for the duration of the contract.

Ninety days prior to the end of the contract year, new price lists or catalogs may be submitted to the Department of Purchasing at 25 Dorrance Street, Suite 408, Providence, RI 02903 (Attention Alejandro Tirado, or his designee). If accepted these price list and catalogs will become effective on the first day of the new contract year. Failure to provide a new price list or catalogs at the appropriate time will result in no adjustment in the base price for the following year.

The bidder shall provide the City user departments with copies of the current manufacturer's catalog within fourteen calendar days of a written request. Manufacturer's web sites may be presented by distributors for informational purposes only.



Method of Payment: Periodic Invoices for Completed Purchases

The bidder(s) shall submit an invoice(s) to the City user department(s) after purchase has been completed, whether the specific item(s) were picked up by authorized City personnel or delivered to the site by the bidder. In addition to the general invoice requirements set forth below, the invoices shall reference the corresponding delivery ticket number or packing slip number that was signed by an authorized representative of the City user department at the time the items were delivered and accepted. Submittal of these periodic invoices shall not exceed thirty (30) calendar days from the delivery of the items. Under no circumstances shall the invoices be submitted to the City in advance of the delivery and acceptance of the items.

All invoices shall contain the following basic information:

IV. Goods or Services Provided per Contract:

- Description
- Quantity

V. Delivery Information:

- Delivery terms set forth within the City of Providence Release Purchase Order
- Location and date of delivery of goods, services, or property

VI. Failure to Comply:

Failure to submit invoices in the prescribed manner will delay payment.



Pick-up and Delivery

The bidder shall make deliveries within thirty calendar days after the date of the order. All deliveries shall be made in accordance with good commercial practice and all required delivery timeframes shall be adhered to by the bidder(s); except in such cases where the delivery will be delayed due to acts of nature, strikes, or other causes beyond the control of the bidder. In these cases, the bidder shall notify the City of the delays in advance of the original delivery date so that a revised delivery schedule can be appropriately considered by the City.

Certain City employees may be authorized in writing to pick-up materials under this contract. Bidders shall require presentation of this written authorization. The bidder shall maintain a copy of the authorization. If the bidder is in doubt about any aspect of material pick-up, the bidder shall contact the appropriate user department to confirm the authorization.

City employees will be given a voucher for up to a maximum of dollar amount to be determined by each department. City employees will use this voucher to pay for any pair of boots/shoes they prefer. If the price of the boots/shoes is higher than the dollar amount in the voucher, the employee will pay the difference at its own expense and not eligible for reimbursement.

Acceptance of Product by the City

The products to be provided hereunder shall be delivered to the City, in full compliance with the specifications and requirements set forth in this contract. If a bidder-provided product is determined to not meet the specifications and requirements of this contract, either prior to acceptance or upon initial inspection, the item will be returned, at bidder expense, to the bidder. At the City's own option, the bidder shall either provide a direct replacement for the item or provide a full credit for the returned item. The bidder shall not assess any additional charge(s) for any conforming action taken by the City under this clause.

Compliance with Federal Standards

All items to be purchased under this contract shall be in accordance with all governmental standards, to include, but not be limited to, those issued by the Occupational Safety and Health Administration (OSHA), the National Institute of Occupational Safety Hazards (NIOSH).

Warranty

Bidders shall guarantee replacement of improperly manufactured items or due to defective materials or product for a one year period after delivery, with replacements being made within two (2) weeks of notification. Replacements shall be in the local store or on the next scheduled visit by the mobile unit, which shall not exceed the two (2) week lead-time. No shoes or boots shall be returned to the factory, unless the original order was placed with the manufacturer. Factory information sheets (specifications, catalog data, etc.) of safety shoes or boots being bid shall accompany the bid proposal as shall any guarantee or warranties. Guarantee information

should include but not be limited to: upper and sole separation guarantee period and water penetration guarantee period, in addition to wearability guarantee.

Rebates and Special Promotions

All rebates and special promotions offered by a manufacturer during the term of the contract shall be passed on by the bidder(s) to the City. It shall be the responsibility of the bidder to notify the City of such rebates and/or special promotions during the contract period.

Special promotions shall be offered by the bidder(s) to the City provided that the new price charged for the item(s) is lower than would otherwise be available through the contract. It is understood that these special promotions may be of a limited duration. At the end of such promotion, the standard contract price shall prevail.

Mobile Units

Those bidders submitting bids based on the utilization of a Mobile Unit as their place of business, must be able to provide services on a regularly scheduled basis (or at mutually agreed upon times), of a fully stocked and staffed vehicle capable of sizing, allowing employees to try on and supplying shoes from its on-board stock to the majority of the employees authorized shoes at the time of its visit. A bidder's repeated inability to maintain it's agreed upon scheduled visit or inability to provide shoes from stock at the scheduled visit may be considered as default of the contract and may be grounds for termination.

The Bidders shall have a stock of shoes and boots, which meet the City's specifications available and on display in their location, and/or on display in their Mobile Unit.

Stock Levels Shall Be Maintained by Bidder

The successful bidder(s) shall ensure that adequate stock levels are maintained at its place of business in order to assure the City of prompt delivery. If the delivery terms specified in the Solicitation are not fulfilled by the Bidder, the City reserves the right to cancel the order, purchase the goods elsewhere, and charge the Bidder for any reprocurement costs incurred by the City.

Substitution of Items During Term of Contract

Substitute brands or models may be considered during the contract period for discontinued models. The bidder shall not deliver any substitute item as a replacement for an awarded brand or model without express written consent of the Department of Purchasing prior to such delivery. Substitute items must be of equal or better quality than the awarded item. Substitutes shall be considered only in emergency situations and excessive substitution requests may be cause to cancel the contract.



Scheduling and Purchase Authorization

Personnel requiring safety shoes and boots shall contact the properly designated Departmental Supervisor to set up the place(s) and time(s) for individual fittings. The Bidder shall be responsible for said fittings at a mutually convenient place and time to be arranged between the City Department(s), the using personnel and the Bidder.

The authorized employees shall be allowed to purchase items under the following condition:

- A. Upon presentation of the proper "Authorization to Pick Up Material" Form, the Bidder shall provide to the employee the item(s) in accordance with the Specifications.
- B. The Department will issue a voucher to the employee, with a Dollar Cap, to purchase the shoes or boots which meet the specifications set forth by the Department, for the employee. The specifications shall be documented on the voucher, by the County Department, in order to restrict the purchase of other types of footwear that do not meet the specifications.
- C. Any Shoes or Boots that exceed the Dollar Cap, established by the User Department, must be pre-approved by the properly designated Department Supervisor, along with the properly completed voucher, based on the departmental guidelines. Additionally, any amount that exceeds the Departments established Dollar Cap, shall be documented by the Bidder along with a copy of the receipt, and notified to the proper Department personnel.
- D. It is the Bidders responsibility to sell only the type of safety shoes or boots specified by the user departments. There shall be no exchange of money between the bidder and County employees.

Scope

The successful bidder(s) shall provide various safety shoes and boots to be purchased by the City of Providence Departments in men's and women's sizes. The bidder shall provide the facility(ies), tools, equipment and the personnel required to size and fit the City employees.

The "facility (ies)" may include a Mobile Unit that will drive out to various City sites, to assist in the selection, sizing/fitting and purchase of Safety Shoes and Boots to City employees. If a Local Store is available, the various City Departments may choose to schedule employees, as appropriate within City or Departmental Guidelines, to go to the store(s) for assistance in the selection, sizing/fitting and/or to purchase the Safety Shoes or Boots.

Authorized employees may also be sent out to pick up orders that have arrived at the Bidder's facility, as may be appropriate.



Special Sizes

Safety shoes and boots shall be made available in sizes ranging from 7 through 13, D, E, EE, EEE (men's) and sizes 6 through 11, Medium, Wide (women's), where applicable.

Charges for sizes other than those shown above shall be shown on pages 18 through 21 and shall be added to the discounted price of the largest sized shoe/boot in the manufacturer's catalog for the brand shoe required.

Specifications

Awarded Bidder(s) shall have the ability to provide a variety of Safety Shoes & Boots in both Men's and Women's sizes, in Medium and Wide widths. All footwear shall be constructed of durable and commercially acceptable materials, such as Leather, Nylon, PVC, Polyurethane, Nitrile, Rubber, or other man-made materials, etc.

The Safety Shoes and Boots offered, shall include but are not limited to the following features:

- a. Steel Toe to meet or exceed ASTM F2412-05 and F2413-05, Class 75 Impact & Compression Standards or latest version.
- b. Shall meet or exceed ASTM, Metatarsal Standards, where applicable.
- c. Shall meet or exceed ASTM, Conductive Standards, to reduce or minimize static electricity and reduce possibility of ignition of volatile chemicals or explosives, where applicable.
- d. Shall meet or exceed ASTM F1116 and F1117 Electrical Hazard Standards or latest version, in order to reduce the potential for electric shock to the wearer when soles are exposed to open circuits under dry conditions, where applicable.
- e. Shall meet or exceed ASTM, Puncture Resistant Standards, which reduce the possibility of puncture wounds to the soles of the feet by objects that could penetrate the soles, where applicable.
- f. Shall meet or exceed ASTM, Electro-Static Dissipative Standards, where applicable.
- g. Shall be constructed in such a manner as to make the footwear 100% Waterproof, where applicable.
- h. Insoles shall be cushioned to minimize or reduce fatigue caused by the extended periods of time standing and/or walking.
- i. Outsoles shall be made of a non-marring material and designed or manufactured in a way as to make them Oil resistant, Chemical resistant, Slip resistant, Heat resistant, Metal Chip resistant and Abrasion resistant for extended periods of time, where applicable.

- j. Footwear soles shall be made in a way which makes them cushioned and shock absorbing.
- k. The Collars and Tongue shall be cushioned so as to provide comfort and support to the ankle, wherever applicable.
- 1. Safety Shoes & Boots shall also be available in styles which provide protection and at the same time are made of a non-metallic material.
- m. Safety Shoes & Boots shall also provide adequate arch support, where applicable.

Store/Mobile Unit Personnel

All authorized personnel assisting the City of Providence employees with sizing and selection of Safety Shoes and Boots shall be sufficiently trained and posses the knowledge and experience to advise proper fitting and correct application for all areas of usage (water, concrete, construction, electrical, grease/oil, chemical, etc.)

CITY OF PROVIDENCE STANDARD TERMS & CONDITIONS

- 1. The terms "you" and "your" contained herein refer to the person or entity that is a party to the agreement with the City of Providence ("the City") and to such person's or entity's employees, officers, and agents.
- 2. The Request For Proposals ("RFP") and these Standard Terms and Conditions together constitute the entire agreement of the parties ("the Agreement") with regard to any and all matters. By your submission of a bid proposal or response to the City's RFP, you accept these Standard Terms & Conditions and agree that they supersede any conflicting provisions provided by bid or in any terms and conditions contained or linked within a bid and/or response. Changes in the terms and conditions of the Agreement, or the scope of work thereunder, may only be made by a writing signed by the parties.
- 3. You are an independent contractor and in no way does this Agreement render you an employee or agent of the City or entitle you to fringe benefits, workers' compensation, pension obligations, retirement or any other employment benefits. The City shall not deduct federal or state income taxes, social security or Medicare withholdings, or any other taxes required to be deducted by an employer, and this is your responsibility to yourself and your employees and agents.
- 4. You shall not assign your rights and obligations under this Agreement without the prior written consent of the City. Any assignment without prior written consent of the City shall be voidable at the election of the City. The City retains the right to refuse any and all assignments in the City's sole and absolute discretion.
- 5. Invoices submitted to the City shall be payable sixty (60) days from the time of receipt by the City. Invoices shall include support documentation necessary to evidence completion of the work being invoiced. The City may request any other reasonable documentation in support of an invoice. The time for payment shall not commence, and invoices shall not be processed for payment, until you provide reasonably sufficient support documentation. In no circumstances shall the City be obligated to pay or shall you be entitled to receive interest on any overdue invoice or payment. In no circumstances shall the City be obligated to

- pay any costs associated with your collection of an outstanding invoice.
- 6. For contracts involving construction, alteration, and/or repair work, the provisions of applicable state labor law concerning payment of prevailing wage rates (R.I. Gen. Laws §§ 37-13-1 et seq., as amended) and the City's First Source Ordinance (Providence Code of Ordinances §§ 21-91 et seq., as amended) apply.
- 7. With regard to any issues, claims, or controversies that may arise under this Agreement, the City shall not be required to submit to dispute resolution or mandatory/binding arbitration. Nothing prevents the parties from mutually agreeing to settle any disputes using mediation or non-binding arbitration.
- 8. To the fullest extent permitted by law, you shall indemnify, defend, and hold harmless the City, its employees, officers, agents, and assigns from and against any and all claims, damages, losses, allegations, demands, actions, causes of action, suits, obligations, fines, penalties, judgments, liabilities, costs and expenses, including but not limited to attorneys' fees, of any nature whatsoever arising out of, in connection with, or resulting from the performance of the work provided in the Agreement.
- 9. You shall maintain throughout the term of this Agreement the insurance coverage that is required by the RFP or, if none is required in the RFP, insurance coverage that is considered in your industry to be commercially reasonable, and you agree to name the City as an additional insured on your general liability policy and on any umbrella policy you carry.
- 10. The City shall not subject itself to any contractual limitations on liability. The City shall have the time permitted within the applicable statute of limitations, and no less, to bring or assert any and all causes of action, suits, claims or demands the City may have arising out of, in connection with, or resulting from the performance of the work provided in the Agreement, and in no event does the City agree to limit your liability to the price of the Agreement or any other monetary limit.
- 11. The City may terminate this Agreement upon five (5) days' written notice to you if you fail to observe any of the terms and conditions of this Agreement, or if the City believes your ability to perform the



terms and conditions of this Agreement has been materially impaired in any way, including but in no way limited to loss of insurance coverage, lapsing of a surety bond, if required, declaration of bankruptcy, or appointment of a receiver. In the event of termination by the City, you shall be entitled to just and equitable compensation for any satisfactory work completed and expenses incurred up to the date of termination.

- 12. Written notice hereunder shall be deemed to have been duly served if delivered in person to the individual or member of the firm or entity or to an officer of the entity for whom it was intended, or if delivered at or sent by registered or certified mail to the last business address known by the party providing notice.
- 13. In no event shall the Agreement automatically renew or be extended without a writing signed by the parties.
- 14. You agree that products produced or resulting from the performance of the Agreement are the sole property of the City and may not be used by you without the express written permission of the City.
- 15. For any Agreement involving the sharing or exchange of data involving potentially confidential and/or personal information, you shall comply with any and all state and/or federal laws or regulations applicable to confidential and/or personal information you receive from the City, including but not limited to the Rhode Island Identity Theft Protection Act, R.I. Gen. Laws § 11-49.3-1, during the term of the Agreement. You shall implement and maintain appropriate physical, technical, and administrative security measures for the protection of, and to prevent access to, use, or disclosure of, confidential and/or personal information. In the event of a breach of such information, you shall notify the City of such breach immediately, but in no event later than twenty-four (24) hours after discovery of such breach.
- 16. The Agreement is governed by the laws of the State of Rhode Island. You expressly submit yourself to and agree that any and all actions arising out of, in connection with, or resulting from the performance of the Agreement or relationship between the parties shall occur solely in the venue and jurisdiction of the State of Rhode Island or the federal court located in Rhode Island.
- 17. The failure of the City to require performance of any provision shall not affect the City's right to

- require performance at any time thereafter, nor shall a waiver of any breach or default of this Agreement constitute a waiver of any subsequent breach or default or a waiver of the provision itself.
- 18. If any term or provision of this Agreement, or the application thereof to any person or circumstance shall, in any extent, be invalid or unenforceable, the remainder of this Agreement shall not be affected thereby, and each term and provision shall be valid and enforceable to the fullest extent permitted by law.
