- SPECIFICATION 004100 BID FORM: <u>REMOVE</u> Pages 2 through 6 of Section 004100 in their entirety and <u>REPLACE</u> with the attached Section 004100 Pages 2 through 6.
- 2. **SPECIFICATION 01025 MEASUREMENT AND PAYMENT**: <u>ADD</u> the following new Paragraph 3.07 and <u>RENUMBER</u> the subsequent sections:

"3.07 PITCHER FILTERS AND REPLACEMENT CARTRIDGES (ITEM 4)

A. General

1. Pitcher Filters and Replacement Cartridges in accordance with Specification 02663 Paragraph 2.10 shall be provided to all locations with a lead service line replacement in accordance with the following:

Single-family home = 1 pitcher filter and filter cartridge(s).

Multi-family home = 1 pitcher filter and filter cartridge(s) per unit.

Commercial = 1 pitcher filter and filter cartridge(s).

If filter cartridge capacity is less than a 6 month supply, provide additional filter cartridges for a minimum total 6 months of filter supply capacity.

B. Measurement

1. Pitcher Filters and Replacement Cartridges – Measurement will be based on the number of pitcher filters (including 6 month supply of filter cartridge capacity) delivered to each unit per the schedule in Paragraph 3.07.A.1 at the time of replacement, including tracking delivery in leadCAST with photographic documentation.

C. Payment

1. Payment for Pitcher Filters and Replacement Cartridges shall be made in full for pitcher filters with 6 months of filter cartridge capacity distributed. All work associated with

ordering, storing, distributing, and tracking confirmation of distribution shall be included under this bid item."

3. **SPECIFICATION 02663 – WATER SERVICE CONNECTIONS:** <u>**REPLACE</u>** Paragraph 2.10 in its entirety with the following new Paragraph 2.10 as follows:</u>

"2.10 PITCHER FILTERS AND REPLACEMENT CARTRIDGES

A. The filters shall be NSF 53 and 42 certified to remove lead under the certification limit at the time of distribution to the customer. The filter shall be:

- 1. Pitcher filter with replacement cartridges both the filter and the replacement cartridges shall be certified to the NSF 53 and NSF 42 standards for removal of lead.
- 2. Provide a minimum 7-cup pitcher filter that supports an NSF 53 and 42 certified filter cartridge.
- 3. A minimum 6-month supply of filter cartridges must be provided at the time of the replacement. Per the manufacturer's specifications, this may be a single 6-month cartridge that is provided with the pitcher filter or an extra box of three replacement (3) cartridges each with a 2-month lifespan, totaling a minimum of 6-months of supply.
- 4. Only full boxes shall be provided to the residents. No unopened or repackage boxes shall be provided even if this results in a greater than 6-month supply of filters.

5. Pitchers and filter cartridge shall be by Brita, PUR, ZeroWater, Dupont or equal.

B. Pitcher filters with replacement cartridges for a minimum 6 month duration shall be provided by the Contractor to each unit in a household following replacements along with instructions for use.

C. Contractor shall track delivery of pitcher filters in leadCAST, including a photograph confirming the delivery.

D. Filters shall be stored by the Contractor in a temperature controlled, dry place for a maximum of 6 months in accordance with the manufacturer's recommendations
