1. QUESTION: Is there any way to instruct each bidder to write their base bid on that first "bidders blank" page? The City of Providence only reads that page at the bid opening, and several contractors always write "unit price bid", which is not correct. There is a total based on the unit prices and it should be written there. Unit price bid is for annual contractors for labor and equipment rates. It is just something that comes up for every bid with Providence Water, and the bidders never know who the low bidder is because of it.
