SPECIFICATIONS

- SPECIFICATION 00 21 13 INSTRUCTIONS TO BIDDERS: <u>ADD</u> new Article 2.3 as follows:
 - 2.3. Bidders must be affiliated with a state or federal registered apprenticeship program as specified in Appendix O.
- SPECIFICATION 00 45 13 BIDDER'S QUALIFICATIONS: <u>DELETE</u> Paragraph 1.01.B and <u>REPLACE</u> with the following:
 - B. Bidders must provide actual number of water service lines replaced (on either the utility side or the customer side) and number of lead water service lines replaced on the customer side (curb to meter) where applicable. The total number must meet the minimum requirements described in Specification 00 21 13 Article 2.2.
- 3. **SPECIFICATION 01180 PIPE PENETRATIONS:** <u>DELETE</u> "or floor" from Paragraph 2.01.C.
- 4. APPENDIX B DETAIL 1a TYPICAL RESIDENTIAL WATER SERVICE CONNECTION ELEVATION/SECTION VIEW: <u>DELETE</u> "EXPANSION TANK AS REQUIRED BY RHODE PLUMBING CODE FOR CONTROLLING PRESSURE INCREASES FROM THERMAL EXPANSION." and <u>REPLACE</u> with "EXPANSION TANK AS REQUIRED BY RHODE ISLAND PLUMBING CODE FOR CONTROLLING PRESSURE INCREASES FROM THERMAL EXPANSION. A MINIMUM OF 2 STRAPS AROUND THE TANK ARE REQUIRED ATTACHED TO A BRACKET FASTENED TO THE WALL."
- 5. APPENDIX B DETAIL 5 FLOOR PENETRATION DETAIL:
 - a. **DELETE** all references to "PVC SLEEVE" and **REPLACE** with "PIPE WRAP TAPE".
 - b. <u>DELETE</u> "SEALANT BETWEEN COPPER SERVICE PIPE AND PVC SLEEVE" in the Isometric Plan View Enlargement.
 - c. **<u>DELETE</u>** Note #2 in its entirety and renumber the succeeding notes.
 - d. <u>DELETE</u> Note #7 and <u>REPLACE</u> with "SERVICE PIPES ENTERING BUILDING THROUGH FOUNDATION WALL SHALL BE INSTALLED AS SHOWN ON DETAIL NO. 4 WITH A WALL SLEEVE AND MECHANICAL SEAL."
