Per the laws of the State of Rhode Island, Sections 44-9-1 et seq., any person having an interest in land sold for the nonpayment of taxes and/or entitled to notice pursuant to R.I. Mortgage Corporation pursuant to Sec 44-9-8.3 and 44-9-25 (c) of the General Laws until after five (5) years from the sale of said property or title for taxes.
